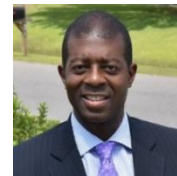

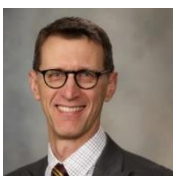

A two-year \$250,000 grant from the John and Wauna Harman Foundation will support a new Duke Divinity School program aimed at reducing racial disparities in advance care planning and overcoming racial inequities in health care. The ACP-HLTF program will strengthen the capacity of the AA ACP/PC Network by developing a group of clinicians, clergy, and scholars whose joint work improves the health and health care experiences of African Americans throughout their lives, with particular attention to the end of life.

Associate Research Professor of Theological Ethics and Bioethics [Patrick T. Smith](#), Faculty Director of the program, will continue the legacy of work led by the late Dr. Richard Payne, who was the Esther Colliflower Professor Emeritus of Medicine and Divinity at Duke Divinity School. Payne, who passed away in 2019, was an internationally known expert in the areas of pain relief, palliative care, oncology, and neurology.

Smith said he looks forward to extending the legacy of Payne's work. "What the Divinity School is uniquely positioned to contribute," he said, "is theological reflection that acknowledges the role of the Black Church in the African American decision-making process—whether medical decisions or end-of-life care decisions—and how that is different from other race and ethnic communities." The goal of this reflection is "not just doctrines, but practices," he

said, and particularly "how embodied Christian practices within faith communities can dramatize what we believe about what it means to die well and live well to the glory of God."

[Maria Mugweru](#), Postdoctoral Associate for the program, said Duke Divinity's role in this work "demonstrates that instead of just a health or legal priority, advance care planning is also faith priority." Before coming to Duke, Maria started a law clinic in Winston-Salem, N.C., that helped community members to access free legal advice and services about Advance Directives. That experience, followed by years as a Hospice Chaplain, led her to see the challenges of not having this conversation early; and, inspired her to find ways to bring up a topic people tend to be hesitant to discuss. "People want to have this conversation over time and with someone they trust," she said. "This naturally flows into faith communities." Her focus is on increasing advance care planning awareness and access between Duke University and Durham's faith community.

Currently, the ACP-HLTF program is building a website with faith-based, end-of-life resources for clergy, clinicians, and researchers. For more information, email ACPNews@div.duke.edu.
