

Dr. Van Scoy was part of a three-person panel discussing whether clinicians are assessing the right outcomes in end-of-life preparation. While completion of an advance directive [via signature and scans into an electronic medical record (EMR)] is a quantifiable goal for research trials, the qualitative and mixed-methods approaches, based on continuous communication, are more successful, though less measurable. Dr. Kinghorn was quoted in [Reformed Journal](#), a digital publication of Christian writings that engages readers in the world in a Reformed way. The 2022 article, “Anxious America: How to Faithfully Respond to the Mental Health Crisis” by Jeff Haanen, reports:

So, what's causing the growing mental health crisis? Many point to a loneliness epidemic. NPR [reports](#) 60% of Americans are lonely, which the pandemic perpetuated when workplaces and schools were shut down, [impacting](#) a generation of young people. The inability to gather during COVID led to fewer in-person relationships, sapping people's resilience to stress.

Many also point to heightened social tensions in the past two years. 'In our culture, we've seen increasing political and social polarization, increasing awareness of sexual assault and racial violence and inequity, and we've had two very polarizing election cycles,' says Kinghorn, a psychiatrist and co-director of the Theology, Medicine and Culture program at Duke University. 'Our experience has been that mental health clinicians are in high demand, especially since the pandemic.'" Kinghorn notes colleges and universities are reporting a significant increase in demand for student mental health services.

Reflections from
Lauren Van Scoy, MD



Less than 25% of individuals in underserved communities have completed an advance directive or talked about their end-of-life wishes with a health care provider. [Project Talk](#), a National Institutes of Health (NIH) funded research project, aims to engage these communities (e.g., ethnic and racial minorities, rural populations, and low-income areas) in advance care planning and empower individuals to start conversations about their end-of-life goals and wishes. Led by [Lauren Van Scoy](#), Critical Care Physician at Penn State College of Medicine, and with the support of [Heather Costigan](#), Research Project Manager for Project Talk, this five-year research study evaluates the impact of three Conversation Tools on engagement with hopes of facilitating high-quality, enjoyable conversations that initiate subsequent actions towards documenting participants' preferences.

The three Conversation Tools assessed:

1. *Hello*

An end-of-life conversation game that prompts players to share their values, goals, and beliefs about end-of-life issues, using a booklet of 32 questions.

2. *The Conversation Project Starter Guide*

An 11-page guide with open-ended prompts that encourages people to talk about their wishes for end-of-

life care, share their wishes, consider their values and preferences, and rank their priorities.

3. *Table Topics*

A popular, commercially available game that consists of question cards to prompt social engagement through light-hearted and fun conversations.

Dr. Van Scoy credits much of Project Talk's success to early support from the late [Dr. Richard Payne](#), Palliative Care Physician and the John B. Francis Chair of Bioethics at the Center for Practical Bioethics, who advocated strongly for her 2015 proposal to the [Parker B. Francis Fellowship](#). Her proposal was the first fellowship funded by the [Francis Family Foundation](#) surrounding end-of-life values and preferences. Dr. Van Scoy's work here led to Project Talk's collaboration between the Penn State College of Medicine, the Hospice Foundation of America, and the University of Kentucky College of Communication and Information.

Collaborating since 2018, the teams published a [national study](#) in the May 2020 JAMA Network issue about the conversation game, *Hello*—funded by the John and Wauna Harman Foundation—that was foundational to the creation of the full Project Talk Trial. In September 2020, the [National Institute of Minority and Health Disparities](#), one of 27 institutes of the NIH, awarded Project Talk \$3.5 million to support its clinical trial research. This was the first grant funded by the NIH for game research related to advance care planning.

Individuals and community-based organizations are encouraged to apply as hosts for advance care planning events. Selected recipients receive training, resources, and a \$300 stipend to support marketing and expenses. For information about becoming a host, see this [flyer](#).
