Efforts were devoted primarily to improving course quality, and streamlining course offerings in an effort to cut costs. Introduced long-term faculty contracts and evaluation mechanisms; arranged for distinguished visiting faculty; organized student advising and university placement. Activities were similar to those of a Chair at a mixed teaching/research university's Economics Department.

Economics Institute: President (January 1990 – December 1996)

The achievements listed (and many others) are not, of course, solely or even mostly due to my efforts: rather, I was fortunate to participate in the exceptional development of an outstanding academic institution. Highlights include:

- operating in the black both on cash and financial bases for all seven years with budget of \$4 million – 5 million USD;
- tripling the size of the Institute's enrollments; doubling faculty and staff;
- overseeing renovation of all buildings; acquisition of new facilities to double the Institute's physical plant to 50,000 square feet;
- establishing permanent research faculty with national recognition;
- establishing overseas programs in Belarus, Korea, Indonesia, Malaysia, Mongolia, Venezuela, Vietnam;
- managed successful transition from exclusive degree preparation to mixed program providing short-term professional training as market shifted;
- success rate of roughly 75% on USAID contracts on which the EI bid; ranked as top short-term program provider (together with CDC) in internal USAID evaluation;
- establishment of decentralized and democratic internal management systems; rigorous budgeting and personnel policies;
- enhanced and extensive relations with University of Colorado and the US academic community at large;
- creation of joint programs with Universities of Colorado (Economics, Journalism), Arkansas (Business), and Illinois (Accounting).

University of Colorado at Denver, Department of Economics, Program in International Business and Economic Studies (PIBES): Co-Director (June 1999 – December 2002)

Developed Business Economics concentration as part of the Economics MA degree. PIBES developed business economics courses, coordinating with other graduate economics courses, and assisted in staffing of these courses. PIBES was also responsible for recruiting and advising international students, and working with sponsors. The program started with 6 students in 1999, and presently grew to roughly 20 MA students, accounting for approximately half of the UCD MA Economics program.

American Economic Association, Summer Program (AEASP) and Minority Scholarship Program: Director (September 2000 – August 2007)

Organized UC-Denver's successful effort to become the eighth host of the AEA's Summer Minority Program, and the first non-doctoral program to do so. Directorship involves course planning and academic program organization, faculty and teaching assistant recruitment, student recruitment and selection, alumni advising and placement assistance, financial management, reporting to the AEA (summary reports to the Executive Committee are published annually in the May *American Economic Review*; detailed reports to the Committee on the Status of Minority Groups in the Economics Profession are available from the AEA), and coordinated with UCD's partner institution, North Carolina A&T State University. Grant writing and fund raising was also a major activity. The Summer Program changed markedly when it came to UCD, with the introduction of two levels of instruction. This enabled recruitment of younger students from less competitive institutions, as these participants can attend both levels over two summers. Applications roughly doubled and enrollments rose approximately 50% with the move to UCD; student satisfaction with the program has also been very high. Oversaw the AEASP's move to Duke University and its further expansion there. The 2005 program had 39 participants, about 30% larger than at UCD; during the program's final year at Duke there were 47 participants. During seven years as director, there were 195 minority alumni, including 38 students who participated in two summers; the average enrollment has been 33 since the program expanded to a two-level (Foundations and Advanced) structure in 2001. Over 100 of these 195 alumni over entered doctoral programs; between 60 and 70 are projected to complete the PhD: for the foreseeable future roughly 8 alumni per year will complete doctorates and enter the job market.

Economics MA program Academic Director, Duke University (August 2003 – present)

Oversaw the academic restructuring of the program and subsequent program growth; planned expansion of course offerings and their integration with AEASP courses. Program size has grown considerably and applicant pool rose from an average of 47 in 2003 and 2004 to an average of 600+ in 2012 and 2013. Introduced standard MA core curriculum, concentrations in (a) economic analysis/PhD preparation, (b) history of political economy, (c) financial economics, and (d) applied economics to complement existing programs; instituted mathematics and econometrics requirements; introduced non-thesis option; introduced January entry option; secured support for internship program. Recent expansion includes tracks in (e) health economics, and (f) computational economics, as well as a Master's in Statistical and Economic Modeling (MSEM) program jointly operated by the Economics and Statistical Science Departments, commencing in August 2012, and which attracted 345 applicants in its first year, and a similar number in 2013. New programs proposed include joint programs with Political Science and Computer Science, and a track in sports economics.
