To participate in the project you must sign Part 1: Privacy Guidelines.

To participate in the project you must sign **Part 2: Release for Publicity Purposes** and indicate whether you **agree or disagree** with your video material being used by DKU for publicity purposes. Note that you must be at least 18 years old to agree to your material being used for publicity purposes. If you are not yet 18 then you are required to disagree.

Optionally, you may also sign **Part 3: Consent to Participate in Research Project** to allow your video material to be used for research purposes.

## Part 1: Privacy Guidelines

DKU students are free to record in the vlogs their own thoughts, feeling and experiences about being a student at DKU. However, in order to maintain privacy and confidentiality, please observe the following rules.

- (1) Record yourself in your own home or dorm room when no-one else is present. Do not film other people in private spaces or otherwise invade their privacy.
- (2) You may include footage taken in public, outdoor spaces, on the DKU campus, or on outdoor DKU educational activities such as field trips, but not inside any buildings or classrooms other than your own room.
- (3) Do not interview other people. We are interested in your own thoughts and feelings. If you want to refer to what other people have said, do so without publicly identifying them. For instance, you can say "one of my professors said..." or "one of my classmates told me that" but do not do so in a way that could indirectly identify those persons, such as "the professor in Math 101 this term" or "the student with the silver earrings who always sits at the front of the class."

If you choose to participate in the research project, you will be given a weekly prompt, and asked to respond specifically to that prompt, but you are free to ignore the prompt if you choose. The prompts will change over time, but will be related to the DKU animating principle of "rooted globalism."

We will need your name in order for you to consent to participate in this research project. We also will keep this signed consent form in a separate and secure location. A unique code number will be assigned to all data we collect from you. However, since you are recording your face and voice, you may be personally identified if a researcher plays a clip of your data as part of a research report and someone in the audience recognizes you. By agreeing that your data may be used for research, you acknowledge that your images and voice may be used in scientific reports or presentations.

#### *Use of Video Material:*

By signing this consent form you grant James Miller the right to use photographs, video, or audio recordings of you in connection with the DKU Rooted Globalism Pilot Documentary Project. You authorize James Miller to copyright, use and publish the photographs, film, and audio recordings in print and/or electronically.

#### *Voluntary nature of participation:*

Participation in this study is voluntary. You can choose not to participate at any point. If you agree to be in the study, you may withdraw at any time for any reason during the data gathering (video-recording) phase. If you choose to withdraw, any data that you have submitted will be destroyed permanently and will not be used for research. However, if you have posted any of your video data on the Internet, or if researchers have made some of your data public in a research report, it may not be possible to completely erase all traces of your images and voice.
