

COLONEL EVEYLON CORRIE MACK

Colonel Eveylon "Corrie" Mack is the Principal Deputy Legal Counsel, Office of the Chairman of the Joint Chiefs of Staff, Pentagon, Washington, D.C. She provides legal advice, through the Legal Counsel, to the Chairman of the Joint Chiefs of Staff in his capacity as the principal military advisor to the President, the Secretary of Defense, and the National Security Council. Colonel Mack also advises the Joint Staff Directorates and the Combatant Commands on international, operational, administrative, and national security law issues.

Colonel Mack received a direct commission as an Air Force judge advocate in 2004 and entered active duty in October 2005, after clerking for Chief Judge H.F. "Sparky" Gierke at the United States Court of Appeals for the Armed Forces. She has served as an instructor in military justice and Senior Trial Counsel, Deputy Staff Judge Advocate at the Joint Special Operations Command, in two



directorates within the Office of The Judge Advocate General, and as a Staff Judge Advocate. She is admitted to practice before the Court of Appeals of Maryland, the Air Force Court of Criminal Appeals, the United States Court of Appeals for the Armed Forces, and the United States Supreme Court.
