CAPT Grant is currently serving as the Fleet Judge Advocate at U. S. Pacific Fleet.

CAPT Grant was born and raised in Charlottesville, VA. He graduated with distinction from the United States Naval Academy in 2000, earning a Bachelor of Science in History. Following the normal Surface Warfare pipeline, he attended Surface Warfare Officer School in Newport, Rhode Island, prior to reporting to his first assignment on board USS ROSS (DDG 71). On USS ROSS, CAPT Grant served as the Electrical and Auxiliaries Officer, and qualified as a Surface Warfare Officer. Shortly after the attacks on September 11, 2001, he deployed with USS ROSS in support of Operation Enduring Freedom. While on deployment CAPT Grant also served as the Boarding Officer of USS ROSS' Visit, Board, Search and Seizure team for conducting Maritime Interdiction Operations.

CAPT Grant served his second tour on board on the USS RONALD REAGAN (CVN 76) as the Assistant First Lieutenant. CAPT Grant was part of the commissioning crew on the USS RONALD REAGAN, and sailed with the ship from Norfolk, VA, around South America to its new homeport of San Diego, CA. In 2004, CAPT Grant was selected for the Law Education Program. After his first year of law school he interned at Region Legal Service Office Mid-Atlantic, and Naval Legal Service Office Mid-Atlantic after his second year. He received his Juris Doctor from the University of Virginia School of Law in 2007.

After completing the Naval Justice School in October 2007, CAPT Grant reported to Naval Legal Service Office Southwest, San Diego, CA, where he served as Defense Counsel, Officer in Charge of the North Island Branch Office and the Legal Assistance Department Head.

CAPT Grant attended the Army Judge Advocate General's School from August 2010 until May 2011 where he earned a Masters in Military Law with a specialty in International and Operational Law.

From June 2011 until July 2012, CAPT Grant served in a Global Support Assignment to Special Operations Command Central. During that year he deployed for six months to a remote Forward Operating Base in Mazar-e-Sharif, Afghanistan, as the Command Judge Advocate for Task Force One Panther (Special Operations Task Force-North). He also deployed to Amman, Jordan, and Doha, Qatar in support of operations.

CAPT Grant served from August 2012 until June 2014 as the Command Services Department Head at Region Legal Service Office Southwest, San Diego, CA. During this tour he assumed duties as the Acting Executive Officer for two months.

From July 2014 to June 2017, CAPT Grant served as Chief of Administrative Law and Assistant Force Judge Advocate for International and Operational Law at US Naval Forces Europe/US Naval Forces Africa/SIXTH Fleet in Naples, Italy.

CAPT Grant was assigned to OPNAV as the Legal Advisor to the Director, Navy Staff from June 2017 to June 2018.

From June 2018 - June 2021, CAPT Grant served as the Chief of National Security Law and Principal Deputy Staff Judge Advocate at U.S. Indo-Pacific Command.

CAPT Grant most recently served as Director of the National Security Law Division (Code 10) within the Office of the Judge Advocate General.

CAPT Grant is a member of the bar in the Commonwealth of Virginia. His military decorations include the Defense Meritorious Service Medal, Meritorious Service Medal with two Gold Stars, Joint Service Commendation Medal, Navy Commendation Medal with Gold Star, Army Commendation Medal, Joint Service Achievement Medal, Navy Achievement Medal with three Gold Stars, and the Army Achievement Medal.
